SECRETARY'S REPORT: Vince F. made a motion to pass, Kevin second, motion approved.

TREASURER'S REPORT: Kevin suggested that the Women's Run pass the RunSignUp fee (\$2.40) on to the registrant. Joe made a motion that all TCRC races using RunSignUp pass the registration fee on to the registrant. Races included would be Forks 15K, Turkey Trot 5-miler, Women's Run and Vestal XX. Aid 5K, NTL's, Octoberfast 5 & 10K. Following a request to time a race in Big Flats, the board declined as there is no-one to head up the finish.

TCRC MERCHANDISE: Sue Cain reported that the order from Upstate Merchandise was not as ordered, and they agreed to issue a refund to TCRC.

BREWERY RUN 8K: Sue proposed that we add this on as a 5th TCRC race. Possible race date of April 14th. It will also include a 1 mile dog walk. All proceeds from the dog walk will go to a charity picked by Michele Bleichert, and all proceeds from the 8K will go to the TCRC. Will bring updated information to September meeting.
